Report of the "3rd Hong Kong Games" Organising Committee

Introduction

This paper seeks to present to the Community Sports Committee (CSC) the activity report of the 3rd Hong Kong Games (HKG) and put forward recommendations for the 4th HKG to be held in 2013.

Background

2. To further promote the "Sport for All" culture in the community, the Sports Commission and the CSC under the Sports Commission, in partnership with the 18 District Councils (DCs), the Sports Federation & Olympic Committee of Hong Kong (SF & OC), the Leisure and Cultural Services Department (LCSD) and relevant National Sports Associations (NSAs), have organised the HKG biennially since 2007. The HKG are a territory-wide major multi-sport event in Hong Kong with the 18 DCs as the participating units. The objectives of the HKG are to provide districts with more opportunities for sports participation, exchanges and co-operation, to encourage active public participation in sports with a view to promoting the "Sport for All" culture in the community, to strengthen the public's sense of belonging to the districts they live in, and facilitate communication and promote friendship among the 18 districts so as to enhance community cohesion. The HKG are organised and co-ordinated by the Sports Commission and the CSC respectively, while the 18 DCs, SF & OC, relevant NSAs and the LCSD are the co-organisers.

The 1st and 2nd HKGs

3. The 1st HKG were held from 21 April to 6 May 2007. A total of 1 287 athletes participated in the competition events of four sports, namely, athletics, badminton, basketball and table tennis, and more than 100 000 people were attracted

to take part in the 12 publicity and public participation activities. The 2nd HKG were held from 9 to 31 May 2009. A total of 2 307 athletes participated in the competition events of six sports, namely, athletics, badminton, basketball, swimming, table tennis and tennis, and more than 160 000 people were attracted to take part in the 13 publicity and public participation activities. In the 2nd HKG, there were substantial growth in the numbers of athletes in competitions and participants in promotional activities, as compared with the 1st HKG. Such encouraging results also indicated that the HKG had gradually gained recognition from the whole community and become a significant sports event held biennially in the territory.

The 3rd HKG

4. The CSC formed the 3rd HKG Organising Committee (OC) in March 2010 for co-ordinating and organising the 3rd HKG. Members of the OC included representatives of the CSC, the 18 DCs, the SF & OC, relevant NSAs, the Home Affairs Bureau and the LCSD. A Standing Committee (SC) was set up under the OC in April 2010. Apart from the representatives of the OC, the SC also comprised representatives from the sports sector, the education sector, the media/public relations sector and the elite athletes, with a view to incorporating views of different sectors as well as planning and implementing various items of the organising work for the 3rd HKG in a more effective way. The structures of the OC and the SC are detailed at *Annex 1*.

Activity Report

Competition Events, the Participants and the Selection Mechanism

5. The 3rd HKG were successfully held from 14 May to 5 June 2011. A total of 3 017 athletes from the 18 DCs participated in the competition events of eight sports, namely, athletics, badminton, basketball, futsal, swimming, table tennis, tennis and volleyball. By means of a standardised selection mechanism, the districts selected athletes meeting the eligibility requirements as their representatives in an open manner starting from August 2010. Each athlete could only participate in the HKG selection competition of one district and could only represent one district in the HKG. A total of 5 147 athletes had participated in the open selection of the districts. After the selection carried out at districts, a total of 3 017 athletes were nominated to represent the 18 districts in the 3rd HKG. Among them, the age group "15 - 19" constituted

the majority (1 061 people, or 35%), followed by the age groups "20 - 24" (638 people, or 21%) and "25 - 29" (363 people, or 12%). The distribution of athletes by age in the 3rd HKG is set out in the table at <u>Annex 2</u>.

6. The various sports competitions were held in the period between 26 March and 4 June on weekday evenings and on Saturdays, Sundays and public holidays to facilitate participation by the athletes of various districts and viewing of the competitions by the public. To minimise the time spent by the athletes on travelling to competition venues far away from their districts, the preliminary round of the team events of ball games were divided into four groups on a geographic basis with a round robin system adopted for each group, such that the matches at this level could be held within the athletes' own regions. Eighty-three events were organised in the 3rd HKG, with 251 medals awarded, namely, 83 gold, 85 silver and 83 bronze. After weeks of fierce and tight competitions, Yuen Long District became the "Overall Champion of the 3rd Hong Kong Games", while the Overall 1st and 2nd Runners-up went to Sha Tin District and Central & Western District respectively. The results of all competitions are set out in the table at Annex 3.

Publicity and Public Participation Activities

7. Held for the third time this year, both the scale and acceptability of the HKG have been growing steadily. To further strengthen the publicity for the HKG and to create a strong atmosphere in the community, the OC had not only adopted the same publicity channels, such as posters, a dedicated website, press releases and advertisements, but also launched a series of new publicity initiatives, including the commencement of various publicity activities as early as in June 2010, and the staging of a launching ceremony to tie in with the 18 districts' athlete selection scheduled to begin in August. For the first time, ten elite athletes were appointed the "Hong Kong Games Ambassadors". Apart from participating in major publicity activities, they also appeared in promotional videos and cheered on the athletes from the 18 districts, as well as calling on all Hong Kong people to support and actively participate in the public participation activities. Meanwhile, two announcements of public interests (APIs) were produced for broadcast on TV and radio channels. These APIs were also uploaded onto the HKG's dedicated website and the ISD on YouTube, and broadcast on public buses, trains and at LCSD venues in the 18 districts. A HKG theme song was also produced for the first time to build up a unique and distinct image for the HKG, so as to reinforce the public's impression of the HKG. Moreover, large-sized advertisements were displayed on tram and bus bodies, in MTR stations and at both entrances of the Cross Harbour Tunnel, in order to create a strong atmosphere for the HKG.

8. In order to encourage public support and participation in the 3rd HKG through different ways, we held a total of 18 diversified publicity and public participation activities. Besides the launching ceremony, the 18 Districts' Pledging Ceremony, the grand Opening Ceremony, the Closing cum Prize Presentation Ceremony, the Elite Athletes' Demonstration and Exchange sessions on the eight sports of the HKG, Voting for "My Favourite Sporty District", Guessing the "Overall Champion of the 3rd HKG" and the "Dynamic Moments Photo Contest", the "Cheering Team Competition for the 18 Districts" was held separately this year and the "Countdown to the 3rd HKG" was introduced. Meanwhile, an exhibition and a large thematic floral wall were set up in the "Hong Kong Flower Show 2011", and display panels were set up in the "Healthy Exercise for All Campaign – Exercise and Health Roving Exhibitions", in order to enhance the publicity effect.

9. In addition, elements of the integration between able-bodied and disabled persons were also introduced to the 3rd HKG. Athletes from the Hong Kong Paralympic Committee & Sports Association for the Physically Disabled and the Hong Kong Sports Association for the Mentally Handicapped were also invited to participate in the Elite Athletes' Demonstration and Exchange sessions of four sports, namely, badminton, athletics, table tennis and swimming, so that different segments of the community could participate in HKG activities.

10. Regarding the awards, new prizes, namely the "Overall 1st Runner-up of the 3rd Hong Kong Game" and "2nd Runner-up of the 3rd Hong Kong Games", were added. Moreover, the "District with the Most Gold Medals" and the "District with the Best Progress" awards were introduced to encourage more active participation in the 3rd HKG by the districts. The 18 publicity and public participation activities of the 3rd HKG had attracted more than 300 000 people, reflecting a more enthusiastic response than the previous two HKGs. The numbers of participants in different activities are set out at <u>Annex 4</u>.

District Delegations and Training Programme and Coach Arrangements for the District Teams

11. In the 3rd HKG, each member of a district delegation could only represent one district, and a member could not take up more than one post/identity in the same

district delegation. All members of the district delegations, including heads, deputy heads, team leaders, coaches and athletes, were not allowed to hold more than one identity, in order to avoid confusion of roles. In order to raise the standard of sports in the districts, the LCSD had allotted 24 hours of training for each of the eight competition events to teams from the 18 districts as a form of pre-competition training through funding under the item on district support in the HKG. This represented a significant increase over the six-hour allotment in the last two HKGs. Moreover, arrangements for provision of systematic training by qualified coaches assigned by relevant NSAs to the district teams were made through the Secretariat (but for table tennis, the districts recruited on their own the qualified coaches who met the Organiser's requirements to provide the training.). During the competition period, the coaches also led the teams to the venues for participation in the competitions, in order to enhance the on-field performance, team spirit and co-operation of the athletes. The recruitment of and remuneration for coaches were handled in accordance with the established recruitment procedure and remuneration rates adopted by the LCSD.

Sponsorship

12. There were two types of sponsors for the 3rd HKG, namely the HKG Sponsors and the HKG District Sponsors. The Organiser received sponsorship of up to \$4.09 million in cash and about \$1.67 million in kind/service from 16 organisations, among which the Hong Kong Jockey Club offered cash sponsorship of up to \$3.5 million and became both the "Principal Contributor" of the 3rd HKG and the Title Sponsor for the futsal competition. The Hong Kong Jockey Club's sponsorship will be used to cover the expenditure on the training of district athletes in the 18 districts for participation in the 3rd HKG, the expenditures on the organisation of the "Elite Athletes' Demonstration and Exchange" for the eight sports and the Title Sponsorship for the futsal competition on a reimbursement basis. In addition, the Yuen Yuen Institute also offered cash sponsorship of \$500,000 and became the "Major Sponsor". The remaining cash sponsorship of \$90,000 was received from six other organisations. The sponsored items included the lucky draw prizes for the Voting and Guessing activities, the track jackets for the 18 district delegations, OC and SC members and the western suits for OC and SC members, the dragon and lion dance performance and the pyrotechnic display at the opening ceremony, drinks for the athletes etc. As for the HKG District Sponsors, response to invitation was also more active than the previous two HKGs, with nine districts (i.e. Central & Western District, Kwai Tsing District, Wan Chai District, Tsuen Wan District, Kowloon City District, Tai Po District, Eastern District, Yau Tsim Mong District and Sha Tin District) obtaining sponsorship from local dignitaries/organisations. The details of the sponsorship from the HKG Sponsors and the HKG District Sponsors are set out at <u>Annex 5</u>.

Financial Arrangements

13. The original estimated funding for the 3rd HKG was HK\$16 million, covering expenditure items such as the expenses for all competitions, publicity activities, the opening and closing ceremonies and the financial support offered to the 18 district teams. To further enhance the publicity for the HKG and promote public awareness of this event, the LCSD had allocated additional funding of \$3 million early This amount, together with the cash sponsorship totalling a maximum of this year. \$4.09 million received by the OC, had given rise to the revised estimated funding of about \$23 million for the 3rd HKG. The additional funding was used mainly for enhancing the major publicity items with a view to creating a stronger atmosphere for the HKG. The expenditure items of the 3rd HKG have yet to be verified for the time being, and it is estimated that the total expenditure of the Games should be around \$21.4 million. The financial statement is set out at Annex 6.

Review of the Activity and Recommendations for the Next HKG

14. To assess the effectiveness of the 3rd HKG and perfect the arrangements for the next HKG, the Secretariat collected views on the 3rd HKG from various sectors of the community in both the organisation process and the course of the Games through different channels such as discussions by the CSC, the advice provided by the Independent Commission Against Corruption, public enquiries, the referrals of public opinions by district councillors and newspaper editorials. Moreover, the Secretariat also issued a pre-designed opinion collection form to the co-organisers after the conclusion of the Games to solicit their opinions on the 3rd HKG. During its sixth meeting held on 13 July 2011, the OC reviewed various arrangements for the 3rd HKG. The key views are at <u>Annex 7</u>.

15. In consolidating the key views from various sectors of the community on the 3rd HKG, the OC considered that the 3rd HKG, which were bigger in scale and showing obvious improvements as compared with the previous two HKGs, had demonstrated a satisfactory overall effectiveness. As the DCs had provided strong support and injected more resources into the Games, stepped up publicity at the district level and mobilised support and participation from local dignitaries, the public's sense

of belonging to the districts they live in had been greatly heightened and community cohesion had been enhanced. In addition, the resources for the 3rd HKG had been greatly increased owing to the support from quite a number of sponsoring organisations. Apart from being used for strengthening the training provided to the district teams and raising the standard of sports among athletes, the resources were also used for enhancing various publicity programmes and enlarging the scale of the whole Games, thereby arousing greater public awareness and encouraging more public participation. The OC has, upon discussion, made the following recommendations for the next HKG:

(a) <u>Positioning and Targets of the HKG</u>

- It was recommended that the present positioning of the HKG as an event for the promotion of "Sport for All" at the community level be maintained for the next HKG so as to work further towards the target of developing a strong sporting culture in the community.
- It was recommended that the overall arrangements for the next HKG be enhanced and the publicity at the district level as well as promotion of competition events be stepped up.

(b) <u>Competition Events</u>

- As the eight existing sports, namely athletics, badminton, basketball, futsal, swimming, table tennis, tennis and volleyball, are already quite all-embracing and popular at the community level, it was recommended that they should be retained in the next HKG. As to whether the number of sports should be increased or not, considerations such as availability of resources in each district and the development of individual sports in the districts should be taken into account.
- If sports are to be added, individual Members were of the view that consideration might be given to triathlon, diving, handball, cycling, squash, wushu, gymnastics for all, chess, dancing and dragon boating.

(c) <u>Co-ordination for Competition Dates and Time</u>

➤ It was recommended that staging of the next HKG during the examination season should be avoided as far as possible and that liaison be made with the relevant NSAs and the Hong Kong Schools Sports Federation, etc. on the competition dates to avoid clashing with the dates of other major sports events or schools competitions. The commencement time of the competitions should be set on the basis of striking a balance between arrangements for competitions and the needs of athletes as far as possible.

It was recommended that holding the finals on two consecutive days or more in the next HKG should be avoided as far as possible to allow athletes sufficient time to get some rest.

(d) <u>Review of the Competition Format and Competition Rules</u>

- The grouping methods, either on a geographic basis or by drawing lots, have their own merits. As most districts generally supported grouping on a geographic basis, it was recommended that this method should continue to be adopted for the preliminary rounds of team events in the next HKG.
- ➤ It was recommended that discussion be held with the relevant NSAs on the possibility of relaxing some of the competition rules in the next HKG and on whether participants or teams could continue to participate in the remaining events and retain the result(s) obtained and the point(s) scored if the participants or teams have withdrawn from any event in the preliminary rounds and the quarter-finals.

(e) <u>Selection of Competition Venues that are Easily Accessible</u>

- ➢ It was recommended that the preliminary rounds (on group basis), which were to be held in different regions, should take place at easily accessible venues located in the districts participating in the respective competition and the quarter-finals be held at conveniently located and easily accessible venues.
- (f) <u>Continued Adoption of the Prevailing Eligibility Requirements for Athletes</u> and Review of the Arrangements Regarding the Roles of Delegation <u>Members</u>
- ➢ It was recommended that the requirement obliging participating athletes to live in the districts they represent be maintained in the next HKG so as to heighten their sense of belonging to the districts they live in and highlight the clear image of the HKG that it is an event with the 18 DCs as participating units.
- It was recommended that the "Entry Qualifying Time" requirement be maintained for the swimming competition in the next HKG.
- It was recommended that the point on whether delegation members, including the heads, the deputy heads and the team leaders, might take up more than one role be further reviewed for the next HKG.
- Regarding the athletes who were nominated to represent their respective

districts in the HKG and then selected to represent Hong Kong in international sports competitions after the enrolment deadline for the HKG, a Member held that they should still be qualified to participate in the HKG so as to reduce the impacts on the district teams. It was recommended that this requirement be reviewed for the next HKG.

(g) <u>Continued Adoption of the Standardised Method of Selecting Athletes at</u> <u>Districts and Selection Mechanism</u>

- It was recommended that the standardised athletes selection mechanism in the 18 districts should continue to be adopted and the restriction that each athlete might only participate in the selection competition(s) of one district be maintained in the next HKG. Discussion should be held with the relevant NSAs on relaxing the eligibility requirements for district selection so as to allow more people to participate in the selection competitions.
- (h) <u>Continued Adoption of the Present Arrangements for District Teams'</u> <u>Training, Coaches and Team Leaders</u>
- ➤ It was recommended that the practice of providing 24 hours of pre-competition training to the district teams for each sports event and the arrangements for the athletes to be led by coaches for participation in competitions be maintained in the next HKG where resources permit so as to raise the standard of sports in the districts. The current method of calculating the fees for coaches who led the teams to the competitions should also be reviewed.
- It was recommended that the DCs should maintain a close tie with schools and sports associations in their own districts for recruiting more district athletes to participate in the HKG so as to avoid domination of participation by a small group of athletes. In the long run, each DC is encouraged to set up district teams for various sports events in the respective district and to provide systematic training with a view to further promoting sports development in the districts and identifying athletes with good potentials in the districts.
- (i) <u>A Publicity Strategy to be Implemented on All Fronts and the Use of More</u> <u>Channels to Enhance Publicity</u>
- It was recommended that continued exploration be carried out to open up more channels to step up publicity for the next HKG and publicity work should begin as early as possible at the district level. The aims are to

promote selection work at districts and continue to step up publicity at the community level during the competition period so as to attract more members of the public to watch the events of the HKG. In addition, a greater variety of activities should be organised to encourage involvement of all Hong Kong people.

- It was recommended that, apart from improving the design of the dedicated website, the efficacy of the website should also be enhanced and upgraded for processing a large set of data.
- It was recommended that the present arrangements for holding the Cheering
 Team Competition separately be adopted in the next HKG.
- In view of the lower participation rate in the Student Division of the photo contest this year as compared with that in the previous HKG, it was recommended that more powerful publicity be carried out for the next HKG.
- (j) <u>Optimising the Sponsorship Programme and Seeking Additional Resources</u> for the HKG
- In view of the growing acceptability of the HKG and the increased number of sponsors, it was recommended that the current arrangements for the sponsorship programme be reviewed for the next HKG so as to increase the resources more effectively and to enhance the image of the HKG.

(k) <u>Improving the Arrangements for the Opening Ceremony</u>

- In view of the fact that members of the public were generally satisfied with the arrangements regarding the programmes of the opening ceremony of the 3rd HKG and particularly praised the excellent military group callisthenics (槍械團體操) performance by the Hong Kong Garrison of the Chinese People's Liberation Army (the Hong Kong Garrison) at the ceremony, it was recommended that the Hong Kong Garrison be invited again to perform at the opening ceremony of the next HKG. Moreover, a Member reflected that as some spectators' seating was on the back side of the performance stage, the needs of all spectators, who were watching the performance from different angles in the venue, should be taken into account when making arrangements for the performances in the next HKG.
- A Member was of the view that the march-in of the delegations at the opening ceremony should be modelled on those marches held at other major sports events, during which the delegations and athletes would enter and march around the venue once, and consideration might be given to cancelling the cheering teams' performance when they enter the venue so as

to ensure a smoother march-in. It was recommended that the arrangements regarding the march-in of the delegations at the opening ceremony be reviewed in the next HKG.

(1) <u>Provision of More Resources for Districts</u>

It was recommended that more resources be provided for districts on a need basis where resources permit in the next HKG and continued encouragement be given to DCs with a view to motivating them to actively seek support and sponsorship from local organisations or dignitaries in order to increase the resources for the district teams to support their participation in the HKG. Publicity should also be stepped up at the district level to encourage involvement of the local residents in the HKG.

District-based Experience Sharing

 \triangleright

16. The competition was keen in all sports events this year. Quite a number of districts achieved outstanding results in the Games, and some of them have shared with us the factors contributing to their success. The factors included:

(a) <u>Stepping Up Publicity at the District Level</u>

Apart from displaying posters, distributing publicity leaflets and displaying large banners and lamp-post bunting, some DCs had allocated additional resources to the stepping up of publicity at the district level. Pamphlets introducing the name lists of district team members and the competition schedules for preliminary rounds were printed for wide distribution and publicity in the districts. Publicity activities such as the pledging ceremony or flag presentation ceremony were held before the Games with the attendance of delegation members and community leaders to encourage public participation and support for the athletes with a view to inspiring them to strive for their best in this year's Games.

(b) <u>Actively Seeking Additional Resources at the District Level</u> Apart from the district support provided by the LCSD, some participating units had actively sought other resources within their districts including DC funding as well as sponsorship from district sports associations and local dignitaries/organisations in order to provide the district teams with additional resources to support their participation in the HKG.

(c) <u>Enhancing Training, Team Spirit and Co-operation among Members of the</u> <u>District Teams</u>

As some districts were provided with additional resources by the DCs or sponsors, more training sessions could be organised with a view to strengthening training for athletes and enhancing co-operation among members of the district teams. This was highly conducive to improving their performance in team events.

(d) <u>Attaching Great Importance to Sports Training at the District Level and</u> <u>Promoting Sports Development in the Districts</u>

Many districts have all along attached great importance to sports development in their districts and engaged actively in the training of sports talents. In view of the fact that the athletes of district teams were chosen through open selection, they actively promoted sports development in their own districts and encouraged their outstanding athletes to participate in the relevant recognised sports competitions so that they could be selected as district representatives through open selection. This has allowed individual districts to be well prepared for the formation of district teams and to strengthen the line-up of their teams.

(e) Local Dignitaries' Enthusiasm and Support for Sports

As some local dignitaries, such as DC Chairmen, District Councillors and District Officers, showed their enthusiasm for a strong sporting culture, they involved themselves actively in the promotion of sports. Apart from holding the pledging ceremony, they greatly boosted the morale of the district teams by going to the competition venues to cheer on the athletes during the competitions.

Conclusion

17. Overall speaking, obvious improvements were seen in the 3rd HKG as compared with the previous two HKGs in terms of the scale and organisation. There was also a marked increase in the level of public participation and support. Held biennially, the HKG are a major sports event to promote sports development in the community and to provide athletes from the 18 districts with an invaluable opportunity for skill exchanges and to learn from one another. Apart from promoting "Sport for

All" in the community, the HKG also strengthen the public's sense of belongings to the districts they live in, foster communication and friendship among the 18 districts and enhance community cohesion. The HKG, first held in 2007, attracted 1 287 athletes to compete in four sports. Each of the HKG held thereafter saw increases in the numbers of sports and participants. The 3rd HKG featured eight sports and the number of participating athletes reached 3 017, an increase of 30% as compared with the number of 2 307 in the 2nd HKG. Moreover, the attendance at the HKG-related publicity and public participation activities this year was over 300 000, an increase of 80% as compared with the attendance of 160 000 in the 2nd HKG. The results were encouraging. Judging from the scale of the Games and the acceptability by the community, the HKG have shown to be more developed and recognised by the whole It has become a major biennial event on the local sports calendar for community. promoting "Sport for All" in the territory.

18. All districts involved themselves actively in organising and preparing for this They showed their excellent organisation ability during the whole year's HKG. course of preparatory work ranging from the selection of athletes, organisation of delegations and arrangements for various types of training to the formation of cheering With the strengthening of the pre-competition training for district teams teams, etc. and the provision of coaches for leading the athletes to the venues for participation in the competitions in this year's Games, the organisation ability and the standard of sports among the district teams have been greatly enhanced. Significant progress was, therefore, brought to sports development at the district level. The participating athletes from the 18 districts fully demonstrated their indomitable spirit and sportsmanship in striving for excellence in various competitions. Through the organisation of and involvement in the HKG, the Government worked closely with the DCs, various NSAs, district sports associations, schools and district sports organisations to jointly promote sports development at the district level, encourage active public participation in sports activities and develop a strong sporting culture in the community.

Formation of the 4th HKG OC

19. The 4th HKG will be held in 2013. In order to allow sufficient time for the launching of organisation work and various publicity programmes, the OC proposed that the 4th HKG OC be formed as early as possible to go ahead with various items of organisation work for the next HKG. In view of the fact that the current DCs will end

their term in late 2011 and cease operation around mid-September the same year for re-election, the OC proposed that the 4th HKG OC could be formed in the first quarter of 2012 the earliest to draw up details including the schedule for the next HKG, the sports competitions, competition format, eligibility requirements for athletes and selection mechanism and roll out various publicity activities as early as possible in mid-2012 in order to tie in with the work on the selection of athletes by the 18 districts which would commence in the latter half of 2012. Assuming that the time for holding the 4th HKG is similar to that of the previous HKGs (i.e. from April to May), we need to start various publicity and public participation activities in early 2013. The proposed work schedule for staging the 4th HKG is at <u>Annex 8</u>.

Key Views from Various Sectors of the Community on the 3rd HKG

(1) Overall Views on the 3rd HKG as well as the Positioning and Effectiveness of the Games

- It was generally opined that the 3rd HKG, which were more systematic in organisation and bigger in scale as compared with the previous two HKGs, had demonstrated a satisfactory overall effectiveness and operated smoothly. The Games were correctly positioned with the right targets and the effectiveness had been achieved as expected to facilitate communication and promotion of sports exchanges among the districts, to promote "Sport for All" in the community, to strengthen the public's sense of belonging to the districts they live in and to enhance the awareness of and the atmosphere for sports participation among all Hong Kong people.
- ➤ As the publicity for the 3rd HKG had been stepped up, public awareness of the Games was raised. With the more powerful publicity carried out in the districts during the competition period, there was a stronger sports atmosphere at the district level as compared with the previous two HKGs.
- A Member held that the degree of participation by both the local residents and the District Councillors of the 18 districts should be further enhanced.

(2) <u>Competition Events</u>

- ➢ It was generally accepted that the eight existing sports were quite all-embracing and it was recommended that they should be retained in the next HKG. Individual DCs indicated that the response to volleyball and futsal, which had been newly added to the 3rd HKG, was less than satisfactory in the districts and it was recommended that they could be replaced by other sports.
- Individual Members suggested that if sports were to be added, consideration might be given to triathlon, diving, handball, cycling, squash, wushu, gymnastics for all, chess, dancing and dragon boating.

(3) <u>Competition Dates and Time</u>

Some Members held that the dates of some competitions of the HKG had fallen on dates near the examination season and some of the competition dates for basketball and futsal had clashed with those for other events organised by the relevant NSAs. Some athletes had thus been affected and were unable to participate in the competitions. Moreover, as most events held on weekdays started at 7 pm, it was suggested that the commencement time of the events be postponed to 7:30 pm and that the events should continue to be held in easily accessible venues to allow athletes sufficient time to go to the competition venues after work.

- A Member held that apart from liaising with the relevant NSAs on the competition dates, co-ordination should also be made with the Hong Kong Schools Sports Federation to avoid affecting students' participation in the competitions and training.
- Some Members held that the holding of some events on two consecutive days had made athletes feel quite exhausted.

(4) <u>Competition Format and Arrangements</u>

- Some DCs suggested that it would be fairer to decide the grouping for the preliminary rounds of team events by drawing lots in the next HKG.
- Some DCs raised the point that a number of athletes were not used to the practice, which have been adopted in other major events, of making no announcements for the roll call in the athletics competition. It was opined that the competition rule of not allowing athletes to participate in the remaining events if they had failed to turn up for any event in the preliminary rounds was relatively strict and hoped that it could be relaxed.
- The Hong Kong Badminton Association suggested that if the participating players/teams had withdrawn from any ranking playoff in the quarter-finals, the point(s) scored for awarding a position could still be retained by the district represented by the players/teams in order to reflect their actual competition results.
- ➤ A Member held that new awards such as the "District with the Most Medals" might be further introduced in recognition of the DC's active participation and excellent performance.
- A District Councillor reflected that the quality of the shuttlecocks used in the badminton competition varied (all shuttlecocks used in the competition met the competition standard).
- On the individual events of the tennis competition, a Member pointed out that the athletes could only participate in one event (if an athlete had participated in the singles event, he/she was not eligible to enter the doubles event) and suggested that the possibility of relaxing the restriction be considered in the next HKG so as to enhance the degree of athletes' participation.

(5) <u>Venue Arrangements</u>

It was generally opined that holding competitions in venues located in remote districts should be avoided and all competitions should be held in venues easily accessible by athletes in the districts.

(6) <u>Eligibility Requirements for Athletes and Identity of Members of District Delegations</u>

Individual districts which had an aging population hoped that the Organiser would consider relaxing the eligibility requirements for athletes, such that students and workers studying and working in their districts respectively could participate in the competitions.

- The Hong Kong Amateur Swimming Association commented that the introduction of the "Entry Qualifying Time" requirement in the swimming competition of the 3rd HKG had achieved the desired effect, as athletes who enrolled in the swimming competition must have achieved the entry qualifying time in the recognised swimming competitions in order to be eligible to participate in the HKG.
- There was general support for the requirement that each member of a DC delegation could only represent one district, and a member could not take up more than one post/identity in the same DC delegation in the 3rd HKG. All members of the DC delegations, including heads, deputy heads, team leaders, coaches and athletes, were not allowed to hold more than one identity, in order to avoid confusion of roles.
- Regarding the athletes who were nominated to represent their respective districts in the HKG and then selected to represent Hong Kong in international sports competitions after the enrolment deadline for the HKG, a Member held that they should still be qualified to participate in the HKG so as to reduce the impacts on the district teams. It was recommended that this requirement be reviewed for the next HKG.
- A Member raised the point that the athletes participating in the 3rd HKG concentrated in the age group of young people (aged between 15 and 24), and it was proposed that people belonging to maturer age groups should be attracted to participate in the HKG.

(7) Method of Selecting Athletes at Districts and the Selection Mechanism

- It was generally agreed that the 18 districts should adopt a standardised selection mechanism for the selection of athletes, in order to avoid complaints arising from different selection methods adopted by the districts. It was also agreed that each athlete should only participate in the selection competition of one district, so as to minimise the likelihood of athletes refusing to represent a district after winning in the selection competition and to comply with the principle of fairness.
- ➤ It was generally agreed that athletes must provide valid proof of place of residence for verification of their eligibility for the HKG when applying for district selection.

(8) <u>Training for the District Teams and Arrangements for Coaches and Team Leaders</u>

- There was general agreement on the arrangements regarding the qualifications and remuneration of coaches and the increase of pre-competition training to 24 hours in the 3rd HKG, which had helped raise the standard of sports among athletes in the districts. Meanwhile, the provision of coaches to lead the athletes to the competitions had effectively enhanced the on-field performance of the athletes and improved the strategic deployment of members within the teams.
- Some DCs reflected that individual athletes' attendance at the training sessions for the district teams was not high because they needed to attend training organised by their own schools or sports teams.
- A Member reflected the views of coaches that the calculation of fees for coaches who led

the teams to the competitions in the 3rd HKG with the method of reimbursing actual expenses involved was unfair to the coaches. It was proposed that the method of calculating fees for coaches who led the teams to the competitions should be reviewed in the 4th HKG.

Some members of the public raised the point that the provision of training for HKG participants had diminished their opportunities to use the sports venues.

(9) Strategies, Channels and Effectiveness of Publicity

- ➢ It was generally agreed that the publicity strategies and channels adopted for the 3rd HKG had been effective, which showed an improvement over the 2nd HKG. The implementation of a series of publicity activities had brought about a significant enhancement in the public's awareness of and involvement in the 3rd HKG.
- ➤ A Member opined that publicity launched by the DCs and that for the district athlete selection should be further strengthened, in order to boost the districts' engagement in the HKG, motivate all Hong Kong people to take part in the HKG, and encourage more people to take part in and watch the high-level sports competitions.
- It was generally agreed that the production of theme song and promotional videos for the HKG had helped promote the event and achieved desirable effects.
- ➢ It was generally agreed that the website of the 3rd HKG was richer in content and more effective as compared with that of the 2nd HKG. However, some Members found the website difficult to log in and some information hard to locate.
- ➢ It was generally agreed that the appointment of elite athletes as "Hong Kong Games Ambassadors" had helped publicise the HKG and achieved positive effects. It could bring about greater effects when publicity was targeted on young athletes.
- ➢ It was generally agreed that the organisation of the cheering competition as a separate activity had given full scope to the talents of the participating teams. The effect was better than that of the 2nd HKG.
- A Members held that publicity for the HKG was more effective in the latter period as compared with publicity carried out in the earlier period. It was proposed that publicity for the 4th HKG should be carried out at an even earlier period with greater force. Extensive publicity should not only concentrate in the period just before the HKG competitions.
- ➤ A Member raised the point that while the lamp post buntings hung during the competitions had achieved good promotional effect, their size was too small and bigger ones should be used in the 4th HKG.
- A Member opined that while publicity on television for the 3rd HKG was adequate and effective, that on the radio and the Internet was relatively weaker. It was suggested that co-operation with radio stations should take place at an earlier stage and publicity through radio programmes should be strengthened.
- A Member pointed out the lower participation rate in the Student Division of the Photo Contest this year as compared with that in the previous HKG and suggested that more

powerful publicity be carried out for the next HKG.

(10) Arrangement for HKG Sponsors and HKG District Sponsors

- There were generally no particular views on the arrangements for the sponsorship of this year's Games. The DCs welcomed that sponsorship was obtained for healthy sports drinks for use in the competitions of the HKG.
- The Hong Kong Badminton Association recommended that sponsorship could be sought from sports goods companies for sponsoring the provision of high quality badminton shuttlecocks for exclusive use in the competitions of the HKG.
- (11) <u>Financial Arrangement</u>
 - Some Members pointed out that the allowance of \$100 for competition uniform per athlete was insufficient as a result of price inflation. It was recommended that the allowance should be increased.
 - ➤ While improvements were shown in respect of items on district support in this year's HKG as compared with the 2nd HKG, it was recommended that the existing funding mechanism should be reviewed and resources for DCs be increased. DCs should also be allowed more flexibility in the use of funds to cover different expenditure items. The allowance for sports uniform for the participating athletes and the formation of cheering teams, etc. should be raised.

(12) Other Views

- Programmes of the opening ceremony had won wide acclaim and satisfaction. A Member said that members of the public particularly praised the excellent military group callisthenics (槍械團體操) performance by the Hong Kong Garrison of the Chinese People's Liberation Army (the Hong Kong Garrison) at the ceremony. It was recommended that the Hong Kong Garrison be invited again to perform at the opening ceremony of the next HKG. Moreover, a Member reflected that as some spectators' seating was on the back side of the performance stage, the needs of all spectators, who were watching the performance from different angles in the venue, should be taken into account when making arrangements for the performances in the next HKG.
- ➤ A Member was of the view that the march-in of the delegations at the opening ceremony should be modelled on those marches held at other major sports events, during which the delegations and athletes would enter and march around the venue once, and consideration might be given to cancelling the cheering teams' performance when they enter the venue so as to ensure a smoother march-in.
- ➤ A Member was of the view that the Organiser should co-ordinate the work of taking out accident insurance cover for the athletes of the 18 districts.
